after defeating SWCL rival Quaboag 2-1 in

a road game last Friday afternoon. "This is a huge rivalry game for us, and it's also a very big win," said Tantasqua senior co-captain Sarah Drajpuch, who scored one of the goals against Quaboag. "We always enjoy playing Quaboag and to beat them not only once, but twice this season is just amazing. We're also hoping to qualify for the state tournament for the first time this year."

The Lady Warriors (7-7-1) swept the season against the young Lady Cougars (6-7-1) for the second consecutive year. They celebrated a 3-1 home victory back on October 13.

"We've beaten Quaboag in the past, but they're a very difficult team for us to play against," said Drajpuch, who's younger sister, Alyssa, is a sophomore and is the goalie for the Lady Warriors j.v. team. "We just came out with a lot of drive and intensity in today's game."

The Lady Warriors other senior co-captain is Claire Godek. Their other seniors are Brooke Cadarette, Anna Talamini, Olivia Viapiano, Alivia Facteau, Francesca Giorgio, Grace Chisholm, and Ella Grant, who was the starting goalie.

Tantasqua j.v. coach Laura McHugh also coached the varsity team in last Friday's game at Quaboag. She took over the coaching duties from varsity coach Shelby Green, who gave birth to a baby girl on October13.

While Tantasqua is ranked 37th in the Division 3 state power rankings, the Lady Cougars are ranked 24th in the Division 4 state power rankings. The top 32 teams in each Division earns a berth in the state

"We play a very difficult regular season schedule against higher Division teams in order to get ourselves ready for tournament play," said John O'Neill, who's wrapping up his 40th season as the Quaboag varsity field hockey coach. "I think we'll be able to qualify for the state tournament this year.'

Following the varsity game, a celebration was held in the gymnasium honoring O'Neill's 40th season. Many of his former players attended the party, along with Patty Provost, who was the longtime varsity field hockey coach at Notre Dame of Worcester.

"Every year that I've coached here has been very special to me," said O'Neill, who has no plans to retire as either a teacher or a coach anytime soon. "I've been very lucky to have been a teacher and a coach at a great school like Quaboag for the past 40 years. It's been a lot of fun coaching these

Following a scoreless first period, the Lady Warriors took a 1-0 lead following a penalty stroke goal with 8:08 remaining in the second period.

The stroke result from a penalty corner shot attempt by Drajpuch. The ball sailed past Quaboag seventh grade goalie Liz Bennington. It would've been a sure goal had it not struck off the foot of a defender, who was standing behind the goalie.

Drajpuch, who's a second year varsity

player, then put a low shot into the Cage. "I take a lot of shots from the 25 and one of my teammates would normally tip it in, but the ball hit the defender's foot on the goal line," Drajpuch said. The only other seniors listed on the Quaboag roster are Margaret Stevens, Kiara Gauthier, and Serenity Kauppila. The duo of Gauthier and Kauppila are tri-captains, along with junior Ayla Iwaniec.

The Lady Warriors held a 2-0 halftime advantage following an unassisted goal by Talamini with 1:39 left in the first half.

Just like in the first period, neither team was able to put the ball into the cage during the third stanza.

The Lady Cougars had four penalty corners and several other shots on goal in the first ten minutes of the final period, but it remained a two goal game.
