

Some vegetables are picky.

They require a little more work, but you love to face the challenge and reap the rewards for your effort. There are a couple of vegetables I will always grow even though they aren't the easiest.

Peppers and onions come to mind. I chuckled as I typed that, since it was dad's all-time favorite pizza combo!

Peppers are demanding. They like warm soil, so we lay down black plastic to pre-warm the earth.

The fruit can scald easily, so we plant them a little closer than you'd think.

Oh yes, although they appreciate the heat of my raised beds, they will require water each and every day if Mother Nature does not provide.

Lastly, patience is required, especially as you wait for them to turn from green to red, orange or yellow. But it's worth it.

Onions too require patience.

Starting the seeds indoors in February to yield a harvest in September is a long-term commitment that is not for the faint of heart.

Weed the bed and weed it again. Water, water, water- onions don't have long roots to support the tops needed to make big bulbs.

Make sure you provide enough nitrogen, but not past the summer equinox. It's all too much, but when that soft-ball sized Alsa Craig wins you a blue ribbon at the local fair you'll be the envy of your neighbor! A few onion braids in the pantry feels good too, that is, if you are the sustainable type. Happy New Year everyone!
