that its activity in the floodplain and wetland will have on the human environment for the Moore and Valley Streets Infrastructure Improvements Project (Phase 1) (hereinafter, the "proposed activity"). There are three primary purposes for this notice. First, people who may be affected by activities in wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of

as a matter of fairness, when the Federal government determines it will participate in actions taking place in wetlands, it must inform those who may be put at greater or continued risk. Funding for the proposed activity will be provided through the U.S. Department of Housing and Urban Development and the Executive Office of Housing and Living Communities, Massachusetts Community Development Block Grant Program.

The proposed activity is intended to update existing water, sewer and drainage infrastructure on Moore Street and Valley Streets. The location of the proposed activities falls partially within a floodplain. Fully compliant water, sewer and drainage infrastructure will improve surface conditions, as well as provide

These supplies will help Dakin to take care of the animals and to keep their areas clean and organized.

Fleagle will also, with the help of some volunteers, be creating no-sew blankets for Dakin.

These blankets will help to give animals a comfortable place to sleep and no-sew blankets have the added advantage of not containing thread, which animals could get caught in or pull at and destroy the blankets.

Any donations to help fund the fleece needed for these blankets would be greatly appreciated. Any cash donations received throughout the supply drive will go toward purchasing fleece for the blankets.

"The fleece is expensive because we need a lot of it, so any amount of fundraising will help with that process," Fleagle said.

Fleagle was inspired to do this project as he cares deeply for animals and wanted to ensure that his Eagle Scout project was something he could truly care for.

"I've always wanted to be able to help animals for an Eagle Project," Fleagle said. "I wanted to do something I really knew I was going to be passionate about, I didn't want to look back at my project and feel like it was something I just did to get it over with."

Fleagle spoke with some of his troop leaders to generate ideas on how he could go about helping animals. They suggested he reach out to local animal shelters to see if he could support them.

Dakin responded quickly to Fleagle's offer and requested the supply fundraiser and the no-sew blankets.

These supply drives can be especially beneficial as animal shelters continue to recover from COVID.

"Following COVID a lot of shelters were struggling to find supplies because of the influx of animals and because COVID took its toll on every business, so I wanted to do what I could to help," Fleagle said.

Fleagle also hopes to help set up a permanent partnership between Smithland and Dakin so that people can continue to donate funding and supplies to the shelter. He hopes that there can be monthly drives so Dakin can continue to be supplied.
