Fr. O'Connor retires from priesthood

ORANGE - Rev. Shaun O'Connor, or Fr. Shaun, as he is known throughout the community, is retiring from the priesthood and leaving Orange, after serving St. Mary's Pastor for almost seven

He plans to travel a bit throughout New England and the eastern seaboard, revisiting some of the places he was stationed during his 42 years in the priesthood. He came to Orange in November of 2017 from Most Holy Redeemer Parish in Hadley.

Fr. Shaun was born in Ottawa, Canada, one of a family of three children, moved to Florida at the age of five and lived mostly in the South before going to Catholic University in Washington, DC, and entering seminary. He went to Graduate Theological University and Jesuit School of Theology in Berkeley.

Names of God Part 7

Scripture employs an array of names for God that speak to His nature and work. In this edition, let us introduce a family of names that center upon the primary name of God in the Old Testament:

YHWH (commonly pronounced as Yahweh). Let us touch upon YHWH Rohi, Shalom and Rapha.

1. YHWH Rohi

YHWH Rohi might be translated as the Lord my Shepherd. It reveals the loving, providential care of God for His people. This title and precept are wonderfully displayed in this timeless selection:

Psalm 23 (NKJV)

1 The LORD is my shepherd; I shall not want.

2 He makes me to lie down in green pastures:

He leads me beside the still

3 He restores my soul; He leads

me in the paths of righteousness

For His name's sake.

4 Yea, though I walk through the valley of the shadow of death,

I will fear no evil; For You are

Your rod and Your staff, they

comfort me. 5 You prepare a table before me

in the presence of my enemies; You anoint my head with oil;

My cup runs over.

6 Surely goodness and mercy shall follow me all the days of my

And I will dwell in the house of the Lord Forever.

2) YHWH Shalom

YHWH Shalom might be translated as the Lord my Peace. God's Word calls us to experience peace in the following arenas:

Firstly, we are called to know peace with God. How can we be at peace in this world if we are at odds with the One who made it? Sin has separated us from the Lord, yet He has made a way for us to come home through the work of Jesus Christ! Scripture is abundantly clear that those who have been justified through faith in Christ possess peace with God (Rom. 5:1).

Secondly, we are called to be at peace with one another. Those who are at peace with God are obligated to pursue peace with their fellow

Romans 12:17-18 (NIV)

17 Do not repay anyone evil for evil. Be careful to do what is right in the eyes of everyone. 18 If it is possible, as far as it depends on you, live at peace with everyone.

Thirdly, we are called to be at peace amidst affliction and adversity. Consider what Jesus had to say concerning such peace:

John 14:27

27 Peace I leave with you; my peace I give you. I do not give to you as the world gives. Do not let your hearts be troubled and do not

3) YHWH Rapha

YHWH Rapha might be translated as the Lord my Healer. This title is born of the pages of the Book of Exodus. Please note:

Exodus 15:22b-26

22 . . Moses led Israel from

the Red Sea and they went into the Desert of Shur. For three days they traveled in the desert without finding water. 23 When they came to Marah, they could not drink its water because it was bitter. (That is why the place is called Marah [i.e., bitter]). 24 So the people grumbled against Moses, saying, "What are we to drink?" 25 Then Moses cried out to the LORD, and the Lord showed him a piece of wood. He threw it into the water, and the water became fit to drink. There the LORD issued a ruling and instruction for them and put them to the test. 26 He said, "If you listen carefully to the Lord your God and do what is right in his eyes, if you pay attention to his commands and keep all his decrees, I will not bring on you any of the diseases I brought on the Egyptians, for I am the LORD, who heals you."

Whereas YHWH Shalom places emphasis upon wholeness of heart and relationships, YHWH Rapha culture around them. places priority upon our physical being. We do well to realize that God cares for us spirit, soul and body! Time and again the Bible presents God as our Healer. To what degree do we revel in this reality, celebrating this aspect of the Lord?

Scripture Reading: Ephesians 3 v 14 - 2

I. Introduction

We know the familiar expression, "Knowledge is power". By doing a Google search, one learns that knowledge can help people make significant decisions, create progress, and guide the future.

Knowledge can give anyone the tools to do what they need or want to do; be creative, develop skills and impart them, and make this world a better place. Everyone has some kind of knowledge about a specific issue, a subject that matters to them. The more we improve our knowledge of something that interests us, the better we are at that specific issue or subject, or practical things we enjoy doing. This world is composed of various forms of knowledge that are applied in all forms to create systems and structures and different fields of work and more. However, knowledge, as we know, can also be used for less constructive pur-

beyond all Knowledge Paul was fully aware of the power of knowledge in the world he lived in. He himself was well educated and familiar with Greek philosophy and culture, and the Acts of the Apostles portrays him as an eloquent speaker. He was immersed in a culture of knowledge, and the churches during his time were therefore also influenced by the riches of knowledge and

In the letter to the Ephesians he prays that they will receive the riches of the power and love of God and Christ, that surpasses all knowledge, and that they will be filled with the fulness of God. What does this mean? First, he asks God to bestow on them out of God's glorious riches, the inner strength and power through the work of God's Spirit.

The riches of God's glory, says Clinton E. Arnold, editor of the Zondervan Commentary on Ephesians, is about God's brilliance, majesty, holiness, and power. Glory represents God in all God's mighty power; and riches is about the superabundance of God's power. Paul continues by saying that God possesses extraordinary might, which God is able and willing to impart to God's people.

While they may know all about earthly knowledge and power, his prayer is that God will bestow upon them a different kind of power, a deep spiritual strength that will transform their lives, and that they will influence the world around them according to God's will and purpose. He continues to pray that they will experience the indwelling of Christ in their hearts, which Arnold describes so beautifully as more of the nearness of

Whatever they need, they will have through the glorious riches and nearness of the power of God inside of them. As young Christians they will experience some struggles in their lives, but with the power of God within, they will have the inner strength to withstand the powerful and destructive forces around them.

But more, they will be rooted in and experience how wide and long and high and deep the love of Christ is that surpasses all knowledge. Being filled with the love of Christ, they too will be inspired to love the way Christ loved humanity. They will be filled with that love, not of their own doing, but through the powerful work of the Holy Spirit inside of them.

This prayer of Paul is powerful and consequential for the believers


