Town Clerk lists election results

HUNTINGTON - The Annual Town Election was held on May 11.

A total of 98 votes were cast for 14 positions and one ballot question. In the only contest on the ballot, John McVeigh won the three-year Board of Selectmen position with 47 votes over challenger Anthony J. Loughran's 42 votes.

For Regional School Committee three-years, Lisa Goding ran unopposed winning with 85 votes. Other unopposed positions on the ballot include: George Peterson III for Board of Health three-years with 84 votes and Moderator with 79 votes, Christine Stochlinski for Board of Assessors three-years with 83 votes, Michelle Fieldstad-Booth for Town Clerk threeyears with 87 votes, H. Daniel Oliveira

for Water & Sewer Commissioner three-years with 86 votes, Charles Dazelle for Constable three-years with 83 votes, Karen Wittshirk for Trustee, Alphonso Pettis Fund three-years with 84 votes and Trustee, Library threeyears with 86 votes.

Several positions on the ballot were filled in by write in candidates, Deresa Helems for Constable 2-years with six votes, Henry Sarafin for Tree Warden 1-year with two votes. Two other positions that failed to elect a candidate were Regional School District two-year and Trustee, Whiting Street Fund three-years.

The ballot question pertaining to changing the Town Clerk position from elected to appointed passed with 52 yes, 37 no and nine blanks.
