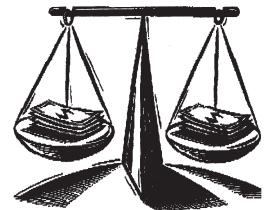
Public Hearing Legal Notice Belchertown Zoning Board of Appeals

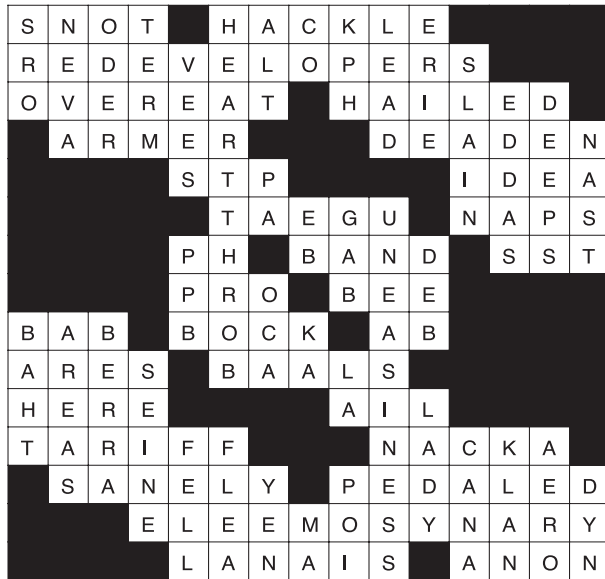
The Sentinel OBITUARY POLICY
