They also offer a delicious coffee stout, which is called "Reveille", which is French for "to wake up", and is also played in the mornings on base. The coffee beans come from Rao's Coffee Roasting Company in Hadley.

Peterson also offers a special Saison, which is their base Saison with blueberry added to it, which is called "Shut Up and Color", another military reference. "We try to have fun with all the names," Peterson said.

Peterson is working on two new beer recipes currently, and one is a Pilsner, and the other a West Coast IPA.

"When I met Chris and CJ, my original plan was to help them financially as an investor," Dave Pare said. "We moved into working together as business partners. I was retired, so I was able to help keep up with the business side of things."

The name Arcpoint, came from Eldridge and Peterson's roles in the Air Force, where they work on airplanes, and it references the GPS the aircrafts use.

"On the GPS, there are three arcs, and where they meet is the arcpoint-where the GPS location and destination is," Eldridge explained.

And that is what the three hope Arcpoint Brewing Company will bea destination that people from all over will be able to utilize in order to enjoy time together.

"It's been amazing. The goal was always to be here in Belchertown. The building is fantastic, and Rick and Sue Staples have been fantastic," Pare said about their business neighbors, RAS Machinery.

"Having this place means everything. This was always the goal, and its fantastic to have that place to engage with people," Peterson said.

"Being able to have this space makes the dream come to life," Eldridge said. "To be able to see it all come together is amazing, and we can now provide a much-needed space for the town."

Arcpoint is a space where veterans are valued, and they are open to being a place to support them, where different veteran organizations can come and have their fundraisers hosted.

"Being able to help with that means a lot," Eldridge said, sharing his heart to those who have served this country like he has.

"My favorite part of this journey was the journey. There's been so many hurdles, but everyone at Town Hall has been so supportive. They knew the town needed this like we did," Pare said.


