Sealed General Bids will be accepted from eligible bidders at the office of the Town Administrator, Finnerty House, 1 South Main Street, Belchertown, Massachusetts 01007 **until 3:00 pm, Friday, 11.15. 2024** at which time they shall be publicly opened. A bid security in the form of a bid bond, cash or certified check in the amount of five percent (5%) of the bid price must accompany the bid.

Selection of the contractor will be based upon bidder qualifications, including evidence of past performance in similar projects, and bid price. In no event shall the mobilization costs exceed fifteen percent (15%) of the total amount of the eligible bid price. The contract will be

awarded to the bidder deemed by the awarding authority to be the lowest responsible and eligible bidder.

The bidder agrees that its bid shall be good and may not be withdrawn for a period of 30 days, Saturdays, Sundays and legal holidays excluded, after the opening of the bids.

The Town reserves the right to waive any informalities, to accept or reject, in whole or in part any or all bids, or take whatever other action may be deemed to be in the best interest of the Town.
