stands for," Ledoux said. "I think it's important to remember that there are people who are diagnosed every single day. There are people getting chemo treatments every single day, there are people sick every single day and I hope that they have the support like the Pink W.A.Y. Foundation provides and with their family and friends while going through this.'

Hector Reyes, lead singer of The Bermudez Triangle, shared the band had a great time performing at the event and encouraged the community to continue lending their support to breast cancer awareness along with supporting local businesses, especially women-owned.

"I would say come out to one of these events. It's very empowering. It's very empowering to see a bunch of vendors--like self-made entrepreneurs--who are out here," Reyes said.
