funded the remaining \$76,000.

Gagliarducci Construction of Springfield was the project's contractor.

P.J. Cambo, member of the Playground and Recreation Commission, praised Gagliarducci Construction's attention to detail.

"It was done right," Cambo said. "The courts are another jewel in the crown of Wilbraham's recreation facilities."

Cambo lauded the "dogged work" done by Litz to see the project through and noted that the site can accommodate lights, seating and a pavilion in the fu-

Pickleball is booming across the country. With the support of the Recreation Department, Elveer Kovarik of Wilbraham started an indoor pickleball group at Memorial School in February 2022 with just a few players. Today that group has nearly 450 members.

The new courts are gorgeous, Kovarik said, and will bring the community

"Pickleball is not just about physi-

cal exercise," Kovarik said. "it's social time.'

Wilbraham-based pickleball structor Dennis Windoloski admired the court's construction. "The colors are great and there's plenty of room to move," Windoloski said. "They are in a nice, secluded spot."

Windoloski believes that access to outdoor courts will likely bring younger players to the sport. "The 35-and-under demographic is the fastest growing group in pickleball," Windoloski noted.

The courts are free to use and will be open to the public until winter weather sets in. Open play at Memorial School's two indoor courts will continue until

Daily indoor pickleball passes, available at the Parks and Recreation office, are \$3 for Wilbraham residents and \$4 for non-residents.

As 24 enthusiastic players swung their paddles on the six new bright-blue courts, Brian Hoar, chair of the Playground and Recreation Commission, predicted: "These courts are going to stay full."
